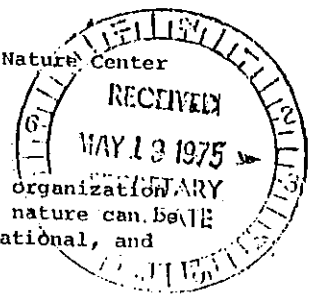

ARTICLES OF INCORPORATION

- (1) The name of the corporation: Greater Ogden Community Nature Center
 - (2) Period of duration: Perpetual
 - (3) Purpose for which corporation is organized:
The nature center will be organized as a non-profit organization for the purpose of providing a center where man and nature can be reunited for education, scientific, cultural, recreational, and spiritual pursuit.
 - Objectives: 65700
 - a. To develop outdoor education and environmental education programs in cooperation with schools, colleges, youth, and adult organizations which will develop an understanding and appreciation of the natural environment and of man's impact on the natural environment.
 - b. To cooperate with national, state, county, and municipal governments, and also private agencies in providing an outdoor and indoor laboratory to involve individuals in environmental problems.
 - c. To provide opportunities for individual and family pursuits of a hobby or a more serious interest in nature.
 - d. To provide a nature study center in close proximity to the population center of Ogden City and Weber County.
 - e. To provide an open area and natural setting free from urban pressures and limitations.
 - f. To serve as a meeting place for serious students and hobbyists of nature.
 - g. To provide work experience in the natural resource area for the community reservoir of youth and retired citizens.
 - h. To develop knowledge, understanding, citizen involvement, interest, appreciation, respect, reverence, responsibility, in all aspects of the natural environment.
 - (4) Members: The corporation will have a membership composed of individuals, groups of individuals, business firms and clubs or organizations. The members will pay annual dues and have voting privileges.
 - (5) No shares will be issued.
 - (6) The property, assets, profits, and net income of this corporation are irrevocably dedicated to charitable purposes and no part of the profits, assets, or net income of this corporation shall ever inure to the benefit of any director, officer, or member thereof or the benefit of any private shareholder or individual. Upon the dissolution, or upon abandonment, the assets of the corporation remaining after payment of or provision for all debts and liabilities of this corporation, shall be donated to the City of Ogden.
