Upon the dissolution, or upon abandonment, the assets of the corporation remaining after payment of or provision for all debts and liabilities of this corporation, shall be donated to the City of Ogden.
- (5) No shares will be issued.

(4) Members: The corporation will have a membership composed of individuals, groups of individuals, business firms and clubs or organizations. The members will pay annual dues and have voting privileges.

- h. To develop knowledge, understanding, citizen involvement, interest, appreciation, respect, reverence, responsibility, in all aspects of the natural environment.
- g. To provide work experience in the natural resource area for the community reservoir of youth and retired citizens.
- f. To serve as a meeting place for serious students and hobbyists of nature.
- e. To provide an open area and natural setting free from urban pressures and limitations.
- d. To provide a nature study center in close proximity to the population center of Ogden City and Weber County.
- c. To provide opportunities for individual and family pursuits of a hobby or a more serious interest in nature.
- b. To cooperate with national, state, county, and municipal governments, and also private agencies in providing an outdoor and indoor laboratory to involve individuals in environmental problems.
- a. To develop outdoor education and environmental education programs in cooperation with schools, colleges, youth, and adult organizations which will develop an understanding and appreciation of the natural environment and of man's impact on the natural environment.
